

## REACH-223 Directive Supplier Declaration

Dear Valued Supplier,

On June 1, 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) entered into force. This Regulation establishes specific duties and obligations for companies in the European Union (EU) that manufacture and import substances on their own, in preparations, or in articles.

Roughly every 6 months the European Chemicals Agency (ECHA) will update the REACH Candidate List. In each update, a number of new Substances of Very High Concern (SVHCs) will be added. Hence, the total number of SVHCs on the Candidate List will increase it is currently set at 223 as of January 17, 2022.




