Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes eye and skin irritation. May cause respiratory and digestive tract irritation. May cause liver and kidney damage. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.
