Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: orange clear liquid.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. Light sensitive.

Target Organs: No data found.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Skin: Causes skin irritation.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated.

Inhalation: Dust is irritating to the respiratory tract. Can produce delayed pulmonary edema.

Chronic: Prolonged or repeated skin contact may cause dermatitis. Effects may be delayed.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid if irritation develops or persists. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.
