### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white to pale yellow solid.

**Warning!** Causes eye, skin, and respiratory tract irritation. The toxicological properties of this material have not been fully investigated.

**Target Organs:** Respiratory system, eyes, skin.

#### Potential Health Effects

**Eye:** Causes eye irritation.

**Skin:** Causes skin irritation.

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
