### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white crystals. **Warning!** Causes respiratory tract irritation. Causes eye and skin irritation.

**Target Organs:** Eyes, skin, mucous membranes.

**Potential Health Effects**

**Eye:** Causes eye irritation.

**Skin:** Causes skin irritation.

**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

**Inhalation:** Causes respiratory tract irritation.

**Chronic:** Effects may be delayed.

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid. Do NOT allow victim to rub or keep eyes closed.

**Skin:** Get medical aid. Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.
