EMERGENCY OVERVIEW

Appearance: colorless to white powder.

Caution! May cause eye and skin irritation. May cause respiratory tract irritation. Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
