### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: pale yellow liquid.

**Caution!** May cause eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

#### Potential Health Effects

**Eye:** May cause eye irritation. Lachrymator (substance which increases the flow of tears). The toxicological properties of this material have not been fully investigated.

### Section 4 - First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.
