Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: colorless to white solid.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. This is expected to be a low hazard for usual industrial handling. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures
