### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: colorless clear liquid. Flash Point: 72 deg C.

**Danger!** Corrosive. Causes burns by all exposure routes. **Combustible liquid and vapor.**

**Target Organs:** Respiratory system, eyes, skin.

#### Potential Health Effects

**Eye:** Causes eye burns.

**Skin:** Causes skin burns. May cause skin rash (in milder cases), and cold and clammy skin with cyanosis or pale color.

**Ingestion:** May cause severe and permanent damage to the digestive tract. Causes gastrointestinal tract burns. May cause burning sensations, coughing, wheezing, laryngitis, shortness of breath and headache.

**Inhalation:** Causes chemical burns to the respiratory tract. Inhalation may be fatal as a result of spasm, inflammation, edema of the larynx and bronchi, chemical pneumonitis and pulmonary edema. May cause burning sensation, coughing, wheezing, laryngitis, shortness of breath, headache, nausea, and vomiting.

### Section 4 - First Aid Measures

**Eyes:** Get medical aid immediately. Do NOT allow victim to rub eyes or keep eyes closed. Extensive irrigation with water is required (at least 30 minutes).

**Skin:** Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Destroy contaminated shoes.

**Ingestion:** Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

**Inhalation:** Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

### Section 5 - Fire Fighting Measures

**General Information:** As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Will burn if involved in a fire. Use water spray to keep fire-exposed containers cool. Combustible liquid. Vapors may be heavier than air. They can spread along the ground and collect in low or confined areas. Containers may explode when heated. ### Section 6 - Accidental Release Measures

Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep container tightly closed. Keep away from heat, sparks and flame. Do not ingest or inhale. Use only in a chemical fume hood. Discard contaminated shoes. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

**Storage:** Keep away from sources of ignition. Store in a cool, dry place. Store in a tightly closed container. Corrosives area.
