EMERGENCY OVERVIEW

Appearance: yellow crystalline powder crystalline powder.

Danger! Corrosive. Causes eye and skin burns. May cause skin sensitization by skin contact. May cause severe respiratory tract irritation with possible burns. May cause severe digestive tract irritation with possible burns.

Potential Health Effects

Eye: Causes eye burns. May cause chemical conjunctivitis and corneal damage.

Ingestion: May cause severe and permanent damage to the digestive tract. Causes gastrointestinal tract burns. May cause perforation of the digestive tract. The toxicological properties of this substance have not been fully investigated. May cause systemic effects.

Inhalation: Causes chemical burns to the respiratory tract. The toxicological properties of this substance have not been fully investigated. Aspiration may lead to pulmonary edema. May cause systemic effects.

Chronic: Effects may be delayed. Repeated or prolonged exposure may cause allergic reactions in sensitive individuals.

Section 4 - First Aid Measures

Eyes: Get medical aid. Do NOT allow victim to rub eyes or keep eyes closed. Extensive irrigation with water is required (at least 30 minutes).

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Destroy contaminated shoes.

Ingestion: Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.
