Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystals. Hygroscopic (absorbs moisture from the air). **Caution!** Causes eye and skin irritation. May cause respiratory and digestive tract irritation. Questionable carcinogen. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.
