EMERGENCY OVERVIEW

Appearance: gray powder powder and chunks.

Caution! May cause respiratory and digestive tract irritation. May cause eye and skin irritation. May cause liver damage. The toxicological properties of this material have not been fully investigated.

Eye: May cause eye irritation.

Section 4 - First Aid Measures
