#### EMERGENCY OVERVIEW

**Appearance:** colorless to light yellow liquid.

**Target Organs:** Respiratory system, eyes, skin.

#### Potential Health Effects

**Eye:** Causes eye burns. Lachrymator (substance which increases the flow of tears).

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.
