EMERGENCY OVERVIEW

Appearance: white to off-white powder.

Warning! Causes respiratory tract irritation. Irritant. Harmful if swallowed, inhaled, or absorbed through the skin. Causes eye and skin irritation. May cause digestive tract irritation.
