### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white powder.

**Caution!** May cause eye, skin, and respiratory tract irritation. May be harmful if swallowed, inhaled, or absorbed through the skin. Material should be stored below -20°C (-4°F).

**Target Organs:** Brain.

#### Potential Health Effects

**Eye:** May cause eye irritation. The toxicological properties of this material have not been fully investigated.

**Skin:** May cause skin irritation. The toxicological properties of this material have not been fully investigated.

**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated. Some references cited on the Sigma-Aldrich website indicate that this substance would affect the brain. They call it a neurotransmitter, say it selectively blocks the N-methyl-D-aspartate subclass of glutamate receptor channels in rat hippocampal neurons, and define it as an endogenous clonidine-displacing substance in the brain.

**Inhalation:** May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated.

**Chronic:** No information found.

### Section 4 - First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

**Ingestion:** If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

**Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
