EMERGENCY OVERVIEW

Appearance: slightly yellow liquid.

Warning! Causes respiratory tract irritation. Irritant. Harmful if swallowed. Causes eye and skin irritation. May cause digestive tract irritation.

Section 4 - First Aid Measures
