Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to yellow crystals.

Warning! Causes severe eye irritation and possible eye injury. May cause respiratory and digestive tract irritation. May cause skin irritation.

Target Organs: Eyes.
