EMERGENCY OVERVIEW

Appearance: white to beige powder.

Warning! Irritant. Causes eye, skin, and respiratory tract irritation.

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation.
