EMERGENCY OVERVIEW

Appearance: almost colorless clear liquid. Flash Point: 90 deg C.

Section 4 - First Aid Measures

Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames. Keep away from heat and flame.
