Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to light yellow crystals.

Caution! Causes eye and skin irritation. May be harmful if swallowed. Causes digestive and respiratory tract irritation. Light sensitive.

Target Organs: None.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. Standard Draize test: Administration onto the skin (human) = 10 mg/48H (Mild).

Ingestion: May be harmful if swallowed. Causes digestive tract irritation.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
