EMERGENCY OVERVIEW

Appearance: beige powder.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Do not use mouth-to-mouth resuscitation if victim ingested or inhaled the substance; induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
