EMERGENCY OVERVIEW

Appearance: orange chunks.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Skin: Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid if irritation develops or persists. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Wash mouth out with water.
