EMERGENCY OVERVIEW

Appearance: clear yellow to brown liquid.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.

Section 4 - First Aid Measures

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.

Section 5 - Fire Fighting Measures

General Information: Containers can build up pressure if exposed to heat and/or fire. As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear.
