Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystals.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Induce vomiting only when instructed to do so by a physician.

Section 12 - Ecological Information

Ecotoxicity: No data available. No information available.

Environmental: May be susceptible to significant leaching in soil. Photolysis on sunlit soil surfaces maybe be possible. No data available for biodegradation in either soil or water. Will hydrolyze relatively rapidly in water at pH 9.65 (no data at pH 7). Bioconcentration, volatilization, and adsorption to sediment are not expected to be important. Will degrade rapidly when released to the atmosphere in the vapor-phase by reaction with hydroxyl radicals. May exist in the adsorbed-particulate phase rather than vapor-phase. Physical removal from the atmosphere may be possible by wet and dry deposition.

Physical: Half-life in water (pH 9.65) = 2.7 hr. Half-life in vapor phase in atmosphere = 4.8 hr (estimated).
