EMERGENCY OVERVIEW

Appearance: white to pale yellow solid.

Caution! May be harmful if swallowed. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Light sensitive. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: May cause eye irritation.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
