Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white powder.

Warning! May cause skin sensitization by skin contact. Causes mild eye irritation. May cause respiratory and digestive tract irritation. May cause skin irritation. May cause adverse reproductive effects based upon animal studies.

Potential Health Effects

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.
