EMERGENCY OVERVIEW

Appearance: white solid.

Warning! Toxic. Harmful if swallowed. May be absorbed through intact skin. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. May cause central nervous system effects. May cause adverse reproductive effects based upon animal studies.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Section 5 - Fire Fighting Measures
