### Section 3 - Hazards Identification

#### **EMERGENCY OVERVIEW**

Appearance: very slightly yellow clear liquid.

Warning! Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. Air sensitive.
