EMERGENCY OVERVIEW

Appearance: almost white solid.

Warning! Causes eye, skin, and respiratory tract irritation. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation.
