EMERGENCY OVERVIEW

Appearance: white to off-white powder.

Caution! May cause skin sensitization by skin contact. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Moisture sensitive. The toxicological properties of this material have not been fully investigated.

Section 4 - First Aid Measures
