### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

**Appearance:** colorless liquid. **Flash Point:** > 93 deg C.

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

### Section 5 - Fire Fighting Measures

**General Information:** As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Use water spray to keep fire-exposed containers cool. Vapors may be heavier than air. **Storage:** Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances.
