### Section 3 - Hazards Identification

#### **EMERGENCY OVERVIEW**

Appearance: clear, colorless clear liquid. Flash Point: -6 deg C.

**Warning!** Flammable liquid and vapor. Causes respiratory tract irritation. Irritant. Causes eye and skin irritation. May cause digestive tract irritation. May cause central nervous system depression.
