Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! May cause allergic skin reaction. May cause eye, skin, and respiratory tract irritation. May be harmful if swallowed. Light sensitive.

Target Organs: Skin.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Xanthidrol was found to be a potent sensitizer in a skin sensitization study in guinea pigs.

Ingestion: May be harmful if swallowed.

Inhalation: May cause respiratory tract irritation.

Chronic: Prolonged or repeated skin contact may cause dermatitis. Xanthidrol has been reported to cause human dermatitis.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid.

Skin: In case of contact, immediately flush skin with soap and plenty of water. Remove contaminated clothing and shoes. Get medical aid if symptoms occur. Wash clothing before reuse.

Ingestion: If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical aid.

Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
