### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: white to off-white solid.

**Warning!** Causes respiratory tract irritation. Causes eye and skin irritation. May cause digestive tract irritation. The toxicological properties of this material have not been fully investigated.

**Target Organs:** None known.

#### Potential Health Effects

**Eye:** Causes eye irritation. May cause chemical conjunctivitis.

**Skin:** Causes skin irritation.

**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

**Inhalation:** Causes respiratory tract irritation. Can produce delayed pulmonary edema.

**Chronic:** Effects may be delayed. Prolonged exposure can cause damage to the eyes, severe irritation or burns.

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin:** Get medical aid. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

**Ingestion:** Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

**Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
