EMERGENCY OVERVIEW

Appearance: faint yellow powder.

Warning! Causes eye irritation. May cause skin and respiratory tract irritation.

Target Organs: Eyes.

Potential Health Effects

Eye: Causes eye irritation.

Skin: May cause skin irritation.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

Inhalation: May cause respiratory tract irritation.

Chronic: Not available. Betahistine dihydrochloride is a vasodilator used as a medicine to treat vertigo, tinnitus and hearing loss associated with Meniere's disease. Reported side-effects include gastrointestinal disturbances, headache, rashes and itching.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid.

Skin: In case of contact, flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical aid if irritation develops and persists. Wash clothing before reuse.

Ingestion: If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical aid.

Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.
