EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes eye, skin, and respiratory tract irritation. Hygroscopic (absorbs moisture from the air). Material should be stored below -20°C (-4°F).

Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid.
