Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to gray white crystals.

Toxic. Warning! Harmful if swallowed. May cause respiratory and digestive tract irritation. May cause eye and skin irritation.

Section 4 - First Aid Measures
