### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: yellow crystalline powder.

**Warning!** Causes respiratory tract irritation. Irritant. Harmful if swallowed, inhaled, or absorbed through the skin. Causes eye and skin irritation. May cause digestive tract irritation. The toxicological properties of this material have not been fully investigated.

#### Potential Health Effects

### Section 4 - First Aid Measures
