EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Causes eye, skin, and respiratory tract irritation. May be harmful if swallowed. Light sensitive. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.
