EMERGENCY OVERVIEW

Appearance: dark green-black powder.

Warning! Harmful if swallowed. Causes eye and skin irritation. Causes digestive and respiratory tract irritation. Light sensitive.

Target Organs: None known.

Potential Health Effects

Eye: Causes eye irritation. Contact may cause discoloration, redness, swelling, and formation of eye lesions.

Skin: Causes mild skin irritation.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.
