Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Warning! Harmful if swallowed. May cause allergic skin reaction. May cause eye, skin, and respiratory tract irritation. May cause adverse reproductive effects based upon animal studies.

Target Organs: Skin.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material.

Ingestion: Harmful if swallowed. May cause irritation of the digestive tract. May cause paralysis of the extremities.

Section 4 - First Aid Measures
