EMERGENCY OVERVIEW

Appearance: slightly brown needles.

Warning! Causes severe skin irritation. Causes eye irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes severe skin irritation. Prolonged and/or repeated contact may cause defatting of the skin and dermatitis. Contact with the skin causes erythema (redness), dryness, and defatting.

Ingestion: May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated.

Chronic: Prolonged or repeated skin contact may cause defatting and dermatitis.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.
