### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: yellow powder.

**Caution!** May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Metabolized to cyanide in the body, which may cause headache, dizziness, weakness, unconsciousness, convulsions, coma and possible death. The toxicological properties of this material have not been fully investigated.

**Target Organs:** No data found.

#### Potential Health Effects

**Eye:** May cause eye irritation.

**Skin:** May cause skin irritation.

**Ingestion:** May cause irritation of the digestive tract. Metabolism may release cyanide, which may result in headache, dizziness, weakness, collapse, unconsciousness and possible death.

**Inhalation:** May cause respiratory tract irritation. May be metabolized to cyanide which in turns act by inhibiting cytochrome oxidase impairing cellular respiration.

### Section 4 - First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.
