EMERGENCY OVERVIEW

Appearance: white crystalline powder.

Caution! May cause eye, skin, and respiratory tract irritation. Moisture sensitive.

Potential Health Effects

Eye: May cause eye irritation.

Section 4 - First Aid Measures
