Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: colorless solid.

Warning! Harmful if swallowed. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. May cause central nervous system depression. May cause bone marrow depression. Light sensitive.

Potential Health Effects

Advanced stages may cause collapse, unconsciousness, coma and possible death due to respiratory failure. May cause anemia, leukopenia (reduction in the number of white blood cells in the blood), and thrombocytopenia. May cause bone marrow depression.

Inhalation: May cause respiratory tract irritation. May cause effects similar to those described for ingestion. The toxicological properties of this substance have not been fully investigated.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
