EMERGENCY OVERVIEW

Appearance: light yellow.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.

Target Organs: None known.

Potential Health Effects

Eye: May cause eye irritation. The toxicological properties of this material have not been fully investigated.

Skin: May cause skin irritation. The toxicological properties of this material have not been fully investigated.

Ingestion: May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated. Contains cyanide. Large doses of cyanide may result in sudden loss of consciousness and prompt death; small doses will prolong the above symptoms 1 to 2 hours.

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated.

Contains cyanide. Inhalation may result in symptoms similar to cyanide poisoning which include tachypnea, hyperpnea (abnormally rapid or deep breathing), and dyspnea (labored breathing) followed rapidly by respiratory depression. Pulmonary edema may occur.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.
