Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: light yellow to green liquid.

Warning! Causes eye, skin, and respiratory tract irritation. Harmful if swallowed. Lachrymator (substance which increases the flow of tears).

Potential Health Effects

Eye: Produces irritation, characterized by a burning sensation, redness, tearing, inflammation, and possible corneal injury. Lachrymator (substance which increases the flow of tears).

Ingestion: Harmful if swallowed. May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid. Do NOT allow victim to rub eyes or keep eyes closed.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.
