EMERGENCY OVERVIEW

Appearance: Clear liquid.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation.

Target Organs: Kidneys, bone marrow.

Potential Health Effects

Eye: Contact produces irritation, tearing, and burning pain.

Section 4 - First Aid Measures
