EMERGENCY OVERVIEW

Appearance: colorless to white crystals. Flash Point: 75 deg C.

Warning! Causes eye, skin, and respiratory tract irritation. Material is a solid at room temperature that melts upon moderate heating into a combustible liquid with a flash point below 200°F(93.3°C).
