EMERGENCY OVERVIEW

Appearance: white to pale yellow solid.

Warning! Causes eye and skin irritation.

Target Organs: Eyes, skin.

Potential Health Effects

Eye: May cause severe eye irritation. Causes eye irritation.

Skin: Causes skin irritation. Amines have been known to cause skin irritation and sensitization. No skin absorption data found.

Ingestion: May cause irritation of the digestive tract.

Inhalation: Material has a low vapor pressure, so exposure to vapor is not likely.

Chronic: Not available. Octadecylamine, a similar chemical, was tested for chronic toxicity in rats exposed through the diet to up to 500 ppm for 2 years. No significant pathological differences between control and test animals were observed.

Section 4 - First Aid Measures

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical aid immediately.

Skin: In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical aid. Wash clothing before reuse.

Ingestion: If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical aid.

Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Notes to Physician: Treat symptomatically and supportively.
